



DATES TO REMEMBER



To: Tehama County Supervisors

From: Red Bluff Fisheries Forum

Dear Members:

The Red Bluff Fisheries Forum supports the appropriate application of the California Endangered Species Act to assure sustainable population levels of Spring Run Salmon.

Since the California Fish and Game Commission is considering an application to list Spring Run under the Act, we ask support of the Board of a position regarding Spring Run Salmon habitat enhancement in Deer and Mill Creek Watersheds in Tehama county.

If the Hayden application is found appropriate and the Commission accepts it for Candidate listing, we the Red Bluff Fisheries Forum ask the Tehama County Board to request that the Commission allows California Fish and Game code sections be applied to afford continuation of beneficial habitat work of the Deer Creek and Mill Creek watershed groups in their efforts on behalf of Spring Run and other wildlife in these unique watersheds. This allowance request is emphasized by Federal qualifications of listing in the case of Winter Run Salmon take at Red Bluff Diversion Dam and at State water project pumps on Clifton Court Forebay.

Note: This position does not state a yes or no on listing, but supports the good efforts of the watershed organizations in case of actual candidate listing which includes full C.E.S.A. compliance. No candidate listing makes the request moot. The statement of the Board, however, is valuable to and deserved by Tehama Citizens who have taken on an important task to protect resources of wildlife, water, and habitat in our County and the State of California.

Finally, the integrity of C.E.S.A. should be maintained to assure a proper solution to the major fish passage problem of the Sacramento-SanJoaquin delta and its water ecosystem.


I respectfully ask the Board to Agendize this request as soon as possible.

Note: This request was unanimously approved by the Board on this date. Thanks from Tehama Fly Fishers and the Red Bluff Fisheries Forum.







