Subject: Meeting April 18, 1997 from 9 a.m. - 3 p.m.

You are invited to a meeting to help craft the workplan for near-term restoration activities based on the work done by individual geographic technical teams. This workplan will be important as we allocate Category III funding this year and additional federal funding we expect to be available in FY 98. We will be meeting on Friday, April 18 from 9 a.m. to 3 p.m. in Room 1412 in the Resources Building.

Now that all the geographic technical teams have met, it is time to bring all the pieces together. We will be distributing a final draft of the San Joaquin team report as well as drafts from the North Bay, American, and the Sacramento and tributaries team meetings next week. The Delta, Suisun and eastside tributaries technical team reports should be available early the week of the April 14. As you review these reports, you will notice that some of the groups prioritized the stressors and limiting factors they identified for their area as well as the types of actions they would recommend to alleviate those problems. Other groups did not prioritize the factors and others did not prioritize the types of actions. In some cases this was because of lack of time and in other cases, they did not believe they had sufficient information to develop the priorities. Some groups were also more specific about the types of actions they would recommend and others provided general descriptions of the types of actions. The task before us is to integrate the relative rankings.
