CALFED Public Workshops on Proposed Draft Alternative

The CALFED Bay-Delta Program is holding public workshops on the recently released Revised Phase II Report. The report includes a discussion of the draft preferred alternative – CALFED’s plan to improve water management and restore ecological health to the Bay-Delta system.

In March 1998, CALFED released a report with three possible solutions to the water and environmental problems in the Bay-Delta. Comments and input from the public, and technical studies and continued analyses by the CALFED staff, stakeholders and state and federal agencies has led to the development of this draft proposal.

The Bay-Delta is critically important to California’s natural environment and economy. It supplies drinking water for two-thirds of Californians and irrigation water for more than 7 million acres of the world’s most productive farmland. It supports 750 plant and animal species. California’s trillion-dollar economy, the seventh largest in the world, is dependent on a healthy Bay-Delta system.

Attend a workshop to learn about the draft proposal and CALFED’s plans for the future. Each meeting will feature a presentation about the draft plan, followed by a question-and-answer period with CALFED staff.
