DWR Review of the CALFED's Draft PEIS/R.

The CALFED Draft PEIS/R was released on March 16 for public review. The comment period closes on June 1. The main document and appendices were sent to the individuals listed on the attachment. I have received inquiries from a few of them regarding DWR's review of the public draft. This memo describes that process.

DWR's review of the draft PEIS/R needs to be thorough but at the programmatic level. We put considerable effort into reviewing the administrative draft. I hope our comments have been adequately addressed and our review of the public draft is fairly easy. However, we need to make sure that is the case. The appendices were not reviewed with the administrative draft so they will require staff review.

The most efficient way I could come up with for the review is to have us, as the CALFED Program Coordination Team members for DWR, be on point for coordinating the review of our respective areas within the Department. David Sandino will be responsible for the Chief Counsel's Office, Randy Brown for ESO, and Dennis Letl for DPLA and the Districts. I will coordinate with O&M and DOE in addition to the Planning Office.

We will be responsible for determining if the comments on the administrative draft PEIS/R from our respective areas have been addressed adequately, for identifying any new issues that have arisen in the draft PEIS/R due to the treatment of other agency comments, and for assuring that the appropriate appendices are reviewed by staff. Each PCT member will coordinate and consolidate the comments from their Office/Division and forward them to Chuck Vogelsang who will prepare the Department's transmittal to CALFED.
